## Contract For Services

Agreement entered into by and between Bride's Name and Groom's Name (hereinafter the "Client") and Night Music Express (hereinafter "NME")

Whereas, the Client desires to engage Emcee's Name and his assistant for NME to provide entertainment of the following type: Disc Jockey Entertainment.

In consideration of the mutual covenants herein contained to be duly kept and performed, the parties hereto to hereby mutually agree as follows:

1. NME shall perform at the premises located at Reception Locations name in Address, City and State on Date Of Reception. The hours of the performance will be approximately Beginning Time to Ending Time. NME will provide all equipment necessary for its performance except electricity.

2. The stipend for this engagement is Fee a non-refundable deposit of Retainer (Personal Check Accepted) to be paid no later than Retainer Due Date. A second non-refundable retainer of 2<sup>nd</sup> Retainer is to be paid no later than Retainer Due Date. The second retainer must be paid in full to guarantee your disc jockey will perform at your event (unless other arrangements are made in advance with NME). The balance of Balance Due (Cash or Personal Check Accepted) to be paid in full on the day of the performance, before commencement of the performance. (Credit Card payment is accepted for balance only if paid five (5) days prior to your event.) It is further understood that any additional time performed by NME, at the request of the Client, shall be paid before the extended period at Overtime Fee. Any agreement to extend the performance past the end time described in paragraph 1, is purely at the discretion of NME. If a cancellation of this engagement occurs after Rescission Date the balance due will be considered outstanding and payable upon cancellation.

3. In the event that NME can not perform the terms of paragraph #1, pursuant to this agreement, due to illness, accident, death or any other unavoidable occurrences, all parties to this agreement, only for those dates that NME could not perform, may be released and discharged of any and all actions or liabilities under this contract. If NME cannot perform, every reasonable attempt will be made to find a suitable replacement on behalf of the said client. If a suitable replacement is found, then the client will be notified of any and all changes; if the client refuses such suitable replacement then NME shall further be released and discharged of any and all actions or liabilities as a result of the cancellation, in part or in whole, of this agreement or for any other conditions or occurrences encountered by any of the parties to this agreement. In such event NME shall promptly refund all monies previously paid by client.

4. NME reserves the right to end a performance at any time, with no refund, due to any situation that may have potential to damage any equipment owned by NME, associates or agents. The decision to end a performance is left to the discretion of NME.

5. This agreement shall not be effective unless signed by all parties and received with deposit by NME on or before the said due date.
